### SECTION 4 - TERMS AND CONDITIONS

#### THE PIG TRAP WILL BE HIRED TO THE APPLICANT SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS

- The applicant agrees to provide the Cassowary Coast Regional Council details of all feral pigs trapped using the Council supplied trap using an approved form (Attachment A). The applicant further agrees to submit these details weekly.
- The trap is only to be used for the control of feral pigs, as a declared pest animal in accordance with the Biosecurity Act 2014 and Cassowary Coast Local Area Biosecurity Plan 2019-2023.
- Traps will only be lent to landholders that have the capacity to effectively and humanely dispose of any pigs under the Animal Care and Protection Act 2001 and agrees to adhere to the guidelines outlined in Trapping Feral Pigs on the Cassowary Coast: A Practical Guide
- Traps may be kept up to a maximum of 28 days at any one time, or a written agreed period.
- Feral pig traps are to remain on the property indicated by the applicant until no longer required or 28 day use period is finished or extension is approved.
- Traps will be available for collection between 2:00-3:30 pm on an agreed date. The date of return will be established at the time of collection.
- Payment of security bond of \$300.00 is to be made at Council offices located at the Civic Centre, 38-40 Bryant Street, Tully, or 57-59 Rankin St, Innisfail, prior to collection of pig trap. This is fully refundable upon the return of the trap in an undamaged condition.
- The applicant agrees to return the trap in good condition to the collection and drop off CCRC depot.
- The applicant agrees that if the trap is damaged or lost, to pay for the repairs or the sum of the replacement of the trap.
- The applicant releases the Council from any claim which it might otherwise have against the Council on any account whatsoever by, through or in connection with the supply of the trap by Council or the use of the trap by the applicant, and the applicant indemnifies the Council against any such claim which might be made against the Council by a third party.
- The applicant acknowledges that in setting and otherwise using the trap, and in dealing with any trapped animal, the applicant does not act as agent of the Council or under any authority conferred by the Council.
- Council reserves the right to refuse the use of the equipment.
- The applicant will reduce risks to capture Non-target native Species by setting traps according to user manual and

releasing non-target animals that are caught but not injured at the trap site. Injured wildlife can be taken to registered wildlife carers or a veterinary clinic.

14. The applicant has been advised that the only way to be sure of avoiding such liability exposed is to treat all trapped animals humanely and in accordance with the laws mentioned above.
15. The applicant grants Cassowary Coast Regional Council personnel the right to access the land on which the trap is located to in accordance to compliance related matters.
