

4.2 NDRRA & DRFA Quarterly Progress Report - September 2020 Executive Summary

Flooding in North Queensland between 6th -10th March 2018 and a Monsoon Trough between 25th January and 14th February 2019 resulted in widespread damage to existing infrastructure within the region of the Cassowary Coast Regional Council (CCRC). This report outlines the progress made to date of the restoration program under the Natural Disaster Relief and Recovery Arrangements (NDRRA) and Disaster Recovery Funding Arrangements (DRFA).

Progress to date consists of:

- 2018 \$ 6,443,969.00
- 2019 \$19,608,175.00

5. ORGANISATIONAL CULTURAL DEVELOPMENT

5.1 Proposed Amendments to Organisational Structure Executive Summary

Chapter 6, Division 2, Section 196 (1) of the Local Government Act 2009 states that a local government must, by resolution, adopt an organisational structure that is appropriate to the performance of the local government's responsibilities.

It follows that any amendments to the organisational structure are also adopted by resolution of Council. This has occurred in recent times with reports presented to Council accordingly.

The first of the proposed amendments is pursuant to changes that have occurred in the Electoral and Other Legislation (Accountability, Integrity and Other Matters) Amendment Act 2020 which result in the Mayor being able to request the role of Mayor's Executive Personal Assistant to perform tasks consistent with guidelines produced by the Chief Executive Officer and also in accordance with the Acceptable Request Guidelines. To support this change, it is proposed that the position of Mayor's Executive Personal Assistant report to the Chief Executive Officer instead of indirectly via the Governance Lead.

The second proposed amendment follows a review of a Senior Planner role after the recent resignation of the incumbent from the role and recommends that the position change to a Technical Officer role based on a change in current and foreseeable building and planning activity and the associated change in nature of assessment and approvals. This proposed change if approved would also result in net savings in the order of \$12,000 p.a. in the remainder of the 20/21 financial year and \$21,500 p.a. in subsequent years.

The organisation chart view of the proposed changes appears at Attachment A.

6. GENERAL BUSINESS

6.1 War on Waste

Cr T Millwood spoke about the War on Waste which was released on Wednesday 7 October 2020 and highlighted people illegally dumping rubbish on nature reserves. There are seven (7) waste facilities in the region that are easily accessible. It is not okay to rubbish in our backyard and if you witness this activity please report it to Council.

Cr Millwood also advised that a visit had been made to the Endeavour Foundation who have currently teamed up with Council to deliver a first for the northern region which is a mattress recycling program. By recycling these mattresses we are helping to keep people in employment and also reducing landfill from approximately 130 cubic metres to 1 cubic metre.

The Mayor also encouraged the community to partner with Council based on the the 3 RRR's - Reduce | Recycle | Report. Council does recycle and is currently recycling 23 items with mattresses being the top item with wet paint and household batteries also recently added to these items. The partnership with Endeavour to recycle mattresses is the first in Queensland and a great outcome for the community and a great legacy to be left for our children.

Appendix 1 - Limitations to the Exercise of Power


- 1 Where Council in its budget or by resolution allocates an amount for the expenditure of Council funds in relation to a particular matter, in exercising delegated power in relation to that matter, the delegate will only commit Council to reasonably foreseeable expenditure up to the amount allocated.
- 2 The delegate will not exercise any delegated power in relation to a matter which, to the delegate's knowledge, adversely affects, or is likely to adversely affect, Council's relations with the public at large.
- 3 The delegate will not exercise any delegated power contrary to a resolution or other decision of Council (including a policy decision relating to the matter).
- 4 The delegate will not exercise any delegated power in a manner, or which has the foreseeable effect, of being contrary to an adopted Council policy or procedure.
- The delegate will only exercise a delegated power under this resolution in a manner which complies with the requirements of Council's Planning Scheme, and any exercise of power which involves a departure from or variation of those requirements will only be undertaken by Council.
- 6 The delegate will not exercise any delegated power which cannot lawfully be the subject of delegation by Council.






Cassowary Coast Regional Council Infrastructure Services - Planning
