Part 1 Preliminary

1 Short title

This subordinate local law may be cited as *Subordinate Local Law No. 6 (Bathing Reserves and Foreshores) 2022*.

2 Purpose

The purpose of this subordinate local law is to support *Local Law No. 6 (Bathing Reserves and Foreshores) 2022* by providing schedules that must be read in conjunction with the local law, which provides for the management and regulation of activities within bathing reserves and foreshores placed under the local government's control.

3 Authorising local law

The making of the provisions in this subordinate local law is authorised by *Local Law No. 6 (Bathing Reserves and Foreshores) 2022* (the **authorising local law**).
