Part 1 Preliminary

1 Short title

This subordinate local law may be cited as *Subordinate Local Law No. 9 (Parking) 2022*.

2 Purpose and how it is to be achieved

- (1) The purpose of this subordinate local law is to support *Local Law No. 9 (Parking) 2022* to regulate parking on local government controlled areas and roads.
- (2) The purpose is to be achieved by providing for:
 - (a) identifying the specified **off-street regulated parking areas**; and
 - (b) providing for the **infringement notice penalty** amounts for **minor traffic offences**.

3 Authorising local law

The making of the provisions in this subordinate local law is authorised by *Local Law No. 9 (Parking) 2022* the **authorising local law**.

This local law repeals -

- (a) Subordinate Local Law No.5 (Parking) 2011.

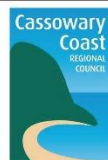


**OFF STREET REGULATED PARKING
