



CASSOWARY COAST REGIONAL COUNCIL REFUSE DISPOSAL CHARGES 2023-2024

Applicable from 1st July 2023 to 30th June 2024

(NB: All fees are GST inclusive)

DOMESTIC Dry and Wet Waste - Shire Residents

May also be referred to as household waste.

Domestic waste includes the material, other than Recycling, that householders place in their general waste bins, or the mixed waste they self-deliver to transfer stations.

Dry and Wet Waste (small) e.g. Car boot, ½ 6x4 trailer, 2 wheelie bins	Up to 0.5m ³	\$8.00
Dry and Wet Waste (medium) e.g. Van, Ute, 6x4 trailer	>0.5m ³ to 2.0m ³	\$16.00
Dry and Wet Waste (large) e.g. Ute and trailer, tandem or large trailer, ute or trailer with side extensions	>2.0m ³ to 4.0m ³	\$22.00

DOMESTIC quantities greater than 4.0m³ will be charged at the Commercial Fee

COMMERCIAL and Domestic (Excluding domestic allowance)

Fees include a waste levy plus GST

- Where weighbridges are available the tonnage rate for material will be used.
- Not all waste types are accepted at all transfer stations. Check with individual transfer station for acceptance criteria.

Asbestos

Asbestos should only be removed and transported by a licenced contractor. Where it is then to be brought to approved landfills with permission sort and granted a minimum of 2 business days prior. More than 175kg or 10 square metres will be required to have a **Waste Tracking Certificate**. Failure to give this notice or Certificate may result in transporters of asbestos being refused entry to site. This condition is in place to allow landfill operators to appropriately prepare disposal areas.

Special Burial/Disposal

Where special burial/disposal is required 48 hours notices should be given where possible.

Council reserves the right to refuse waste or direct customers to alternate facilities.
