THE ROLE

Division:

The Environmental Health Officer, reporting to the Principal Environmental Health, will work collaboratively with the Environmental Health team to maintain and improve community environmental and public health conditions through education, advocacy, assessment of compliance and enforcement. Environmental health and protection duties will include inspection programs, assessment of business and community compliance with relevant legislation, assistance with disaster management, noise assessments, and water and food sampling.

The role will be based in Innisfail, however, work will require travel across the whole Cassowary Coast Region.

- Implementation of Regulatory Services Compliance and Enforcement Guidelines, promoting a risk-based approach to enforcement focusing on information and education
