Cat and Dog Trap Hire Form

Conditions:

- The trap is to be returned clean and undamaged. Damaged traps will be replaced by the hirer at the prescribed fee (refer below).
- Traps can be collected from the Council's Customer Service Centres at Innisfail or Tully. Alternatively, traps can be delivered at a fee (refer below).
- Clean traps are to be returned to the Customer Centre where it was collected.
- If an animal is trapped, the hirer is to ensure the animal is cared for in accordance with the *Animal Care and Protection Act 2001* including food, water, shelter and the physical wellbeing of the animal.
- Trapped animals can be impounded by Council. Please contact Council on 1300 763 903 to arrange to transfer the animal to either the Innisfail or Tully pound.

After 30 days if the trap is not returned the trap will be deemed lost and the hirer will be invoiced the cost of the trap – per trap	\$ 215.00
